

How to establish state sales tax exemption on your TESSCO account:

- Select the applicable certificate(s) from the list of common state certificates below, relating to your ship to locations and your exemption type *for any state in which you are registered to collect sales tax*.
- If you are exempt for reasons other than resale and there is no Exemption Certificate listed below, please forward your state-issued Exemption Certificate (do not complete a Resale Certificate unless you are a reseller).
- Forward completed, signed certificate(s) to SalesTax@TESSCO.com or fax to [410-229-1619](tel:410-229-1619).
- Include your TESSCO account # (if known) on your fax or email.

PLEASE BE ADVISED:

- TESSCO can accept only documents that are complete, signed, and dated.
- Please do not send tax permits/licenses/registrations/W9s. Exemption can not be established using these documents.
- TESSCO is not currently registered to assess, collect or remit sales tax for states listed on page 3. No tax will be billed. You must accrue and pay tax directly to the state.
